- (i) Upto 3 or more paper Rs. 850/- + Rs. 60/- (Memorandum of Marks)
- (ii) Less than 3 papers Rs. 650/-+Rs.60/- (Memorandum of Marks)

A Xerox Copy of Medical Certificate confirming their status as disabled Handicapped. (Minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

(b) Inform the students that the examination fee & application forms will not be accepted after the due date.

(c) Instruct the students to enclose the photo copies (Xerox copies) of the memorandum marks of qualifying examination to verify the eligibility.

4. The Principals are requested to forward all the Examination application forms duly attested on or before **18.06.2018** without fail.
