NOTE:

- 1. The Examination application forms are to be submitted online through college login. Also hard copy of the same may be downloaded and submitted to the examination branch duly signed by the student and the principal concerned along with photocopy of memo.
- 2. The examination fee once paid by the candidate/college will not be refunded or adjusted.
- 3. The Principals of the Under Graduate colleges of Mahatma Gandhi University are requested to:
 - (a) Inform the students that the examination fee and application forms will not be accepted after the due date.

- (b) Instruct the students to enclose the photo copies (Xerox copies) of the Memorandum of marks of the qualifying examination to verify the eligibility.
- (c) Submit all the application forms along with the consolidated statement of fee collected from the students (in any case individual receipts submitted by students will not be accepted)
- 4. Nominal Rolls: One hard copy of nominal rolls (consolidated list of candidates) generated using the students online information system after due verification by the Principal. Fees abstract (In duplicate) to be submitted to Examination Branch.
